## **EYES ON THE BABY - ELIGIBILITY CRITERIA**

**MULTI-AGENCY SUDI PREVENTION IN NORTHUMBERLAND** 





THE EYES ON THE BABY PROJECT IS A RESEARCH PROJECT TO PROVIDE AND EVALUATE MULTIAGENCY TRAINING FOR STAFF WORKING WITH NORTHUMBERLAND RESIDENTS. THE PROJECT IS FUNDED BY NORTHUMBERLAND COUNTY COUNCIL, NORTHUMBERLAND FAMILY HUBS AND NORTHUMBRIA HEALTHCARE NHS FOUNDATION TRUST.



THE TRAINING IS PROVIDED FOR MULTIAGENCY STAFF WHO WORK IN NORTHUMBERLAND OR WITH NORTHUMBERLAND RESIDENTS.



IT IS RECOGNISED THAT SOME AGENCIES AND ORGANISATIONS WORK ACROSS LOCAL AUTHORITY BOUNDARIES. STAFF ARE ABLE TO ACCESS TRAINING IF A SIGNIFICANT AMOUNT OF THEIR TIME (I.E. MORE THAN 50%) BETWEEN SEPTEMBER 2023 AND MARCH 2024 INVOLVES WORKING WITH NORTHUMBERLAND RESIDENTS.



THIS PROJECT EVALUATES THE IMPACT OF THIS TRAINING IN NORTHUMBERLAND. STAFF SHOULD ONLY PARTICIPATE IN THE EVALUATION IF THEY SPENT A SIGNIFICANT AMOUNT OF THEIR TIME (I.E. MORE THAN 50%) BETWEEN SEPTEMBER 2023 AND MARCH 2024 WORKING WITH NORTHUMBERLAND RESIDENTS.



PLEASE NOTE: THE SAFE SLEEPING INFORMATION PROVIDED IN THE TRAINING IS RELEVANT FOR ALL PARENTS. HOWEVER, THE INFORMATION ABOUT SPECIFIC SUPPORT SERVICES AND ASSOCIATED CARE PATHWAYS DESCRIBED IN THE TRAINING ARE ONLY APPLICABLE TO NORTHUMBERLAND RESIDENTS. ALL STAFF WHO WORK ACROSS LOCAL AUTHORITY BOUNDARIES WHO UNDERTAKE EYES ON THE BABY TRAINING SHOULD REMEMBER TO USE APPROPRIATE LOCAL SUPPORT SERVICES AND PATHWAYS FOR PEOPLE WHO ARE NOT NORTHUMBERLAND RESIDENTS.
